

Kenny Chesney Concert Tickets Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The Kenny Chesney Concert Tickets Sweepstakes ("Sweepstakes") begins **May 1, 2018** and ends **July 5, 2018** ("Sweepstakes Period"). The Sweepstakes is sponsored by James B.
